Cisco announces the end-of-sale and end-of-life dates for the Cisco 8-Port Channelized T1/E1 Shared Port Adapter. The last day to order the affected product(s) is May 19, 2014. After this date, all support services for the product are unavailable, and the product becomes obsolete. | May 31, 2019 |
