

# End-of-Sale and End-of-Life Announcement for the Intel Xeon Processors E5-4600 v1 Series

#### EOL10221—Amended

Cisco announces the end-of-sale and end-of life dates for the Intel Xeon Processors E5-4600 v1 Series. The last day to order the affected product(s) is February 6, 2016.
