

# End-of-Sale and End-of-Life Announcement for the Cisco Select Cisco StorMagic OEM SW

Cisco announces the end-of-sale and end-of-life dates for the Cisco Select Cisco StorMagic OEM SW. The last day to order the affected product(s) is April 17, 2017.
