For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions.

All of the PIDs on this announcement will be orderable per the scheduled Last Ship Date below provided we are able to procure all of the components required to manufacture the products through that date.
