

End-of-Sale and End-of-Life Announcement for the Cisco Prisma II EDR Receivers with OPM Modules

Cisco announces the end-of-sale and end-of-life dates for the Cisco Prisma II EDR Receivers with OPM Modules. The last day to order the affected product(s) is August 28, 2019. Customers with active service contracts or active warranties will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions.

Cisco is announcing the discontinuation of the sale of PII EDR Receivers which are pre-populated with the standard range or extended range Optical Pluggable Modules (OPMs). Future sales of PI EDR Receiver modules and OPM modules will have to be made separately. We still offer the same products just not with a PID which combines them.
